

MENOMINEE NATION MENOMINEE TRIBAL LEGISLATURE MTL AMENDMENT #9 TO ORDINANCE NO. 22-42 FISCAL YEAR 2023 APPROPRIATIONS

FINAL APPROVAL

BE IT ORDAINED BY THE LEGISLATURE OF THE MENOMINEE INDIAN TRIBE OF WISCONSIN:

- **1. PURPOSE.** This amendment increases the Fiscal Year 2023 Appropriations by \$101,995 as follows:
 - 1.01 Increase Pow-wow Menominee Nation Annual by \$31,995
 - 1.02 Increase Burial Fund by \$70,000
 - 1.03 Increase Transfers from General Fund by \$101,995.
- **2.** This amendment increases the total Appropriations of \$27,611,431 to \$27,713,426.
- **3. AMENDMENT.** The tabular summary of anticipated fund revenues and expenditures, entitled EXHIBIT "A", which was attached to and made a part of Menominee Tribal Ordinance No. 22-42, entitled "Fiscal Year 2023 Appropriations", is hereby replaced in its entirety with the attached revision. All other terms, conditions, and provisions of Ordinance No. 22-42 not specifically listed in this amendment are unchanged and unaffected.
- **4. EFFECTIVE DATE.** This amendment shall become effective immediately upon final approval by the Menominee Tribal Legislature.
