

TOWNSHIP OF MOORESTOWN

ORDINANCE NO. 2-2023

**AMENDING CHAPTER 168 OF THE CODE OF THE TOWNSHIP OF MOORESTOWN
ENTITLED “VEHICLES AND TRAFFIC”**

WHEREAS, it has come to the attention of the Township that students have been parking on streets located near school properties during the school day causing public safety concerns, disruption, and inconvenience to the residents; and

WHEREAS, it is in the best interest, safety, and wellbeing of the residents to amend Chapter 168 to address concerns.

BE IT ORDAINED by the Township Council, of the Township of Moorestown, in the County of Burlington, State of New Jersey that:

Section 1. “§168-68. Schedule XVIII: Time Limit Parking” of the Code of the Township of Moorestown is hereby amended by adding the following language:

<u>Tyndale Court</u>	<u>Both</u>	<u>2 hrs: 7:00 a.m. to 11:00 a.m.</u> <u>School Days</u>	<u>Entire Length</u>

Section 2. Regulatory signs shall be erected and maintained to effectuate the above-designated “2 Hour Parking 7:00 a.m. to 11:00 a.m. School Days.”

Section 3. In all other respects, Chapter 168 shall remain in full force and effect.

Section 4. Repealer. Any and all other ordinances inconsistent with any of the terms and provisions of this ordinance are hereby repealed to the extent of such inconsistencies.

Section 5. Severability. In the event that any section paragraph, clause phrase, term, provision or part of this ordinance shall be adjudged by a court of competent jurisdiction to be invalid or unenforceable for any reason, such judgment shall not effect, impair or invalidate the remainder thereof, but shall be confined in its operation to the section, paragraph, clause, term, provision or part thereof directly involved in the controversy in such judgment shall be rendered.

Section 6. Effective Date. This ordinance shall take effect upon proper publication in accordance with law.

Section 7. Short Title. This Ordinance shall be known as Ordinance No. 2-2023.
