A local law AMENDING Section 13-2-2, 13-2-2.1 and 13.2-2 of the Zoning Ordinance of the Town of

LEGISLATIVE INTENT: Due to the increasing number of matters coming before the Zoning Board of Appeals in recent years, and the increase in costs and expenses in the publication and mailing of notices of public hearing for said matters, it has become necessary to adjust the time periods and costs inherent to the publication, mailing and posting of said notices of public hearings set forth in Sections 13-2-2, 13-2-2.1 and 13-2-2.2 of the Town of Newfane Zoning Ordinance.

§13-2-2 is hereby AMENDED to read as follows: The board shall fix a time and place for a public hearing thereon, and shall provide for the giving of notice at least 5 days prior to the date hereof as follows:

§13-2-2.1 is hereby AMENDED to read as follows: By publishing a notice in the official newspaper and sending a notice by regular first class mail to the owners of properties within 300 feet of the property affected by the proposed application, including properties on the opposite side of the street or highway.

§ 13-2-2.2 is hereby REPEALED in its entirety.

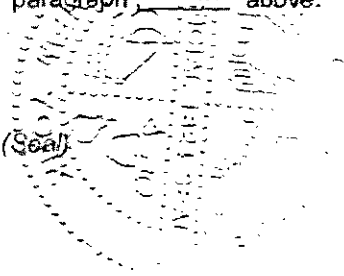
