



**TOWNSHIP OF NORTH FAYETTE
RESOLUTION NO. 23-24**

A RESOLUTION OF THE TOWNSHIP OF NORTH FAYETTE, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, AUTHORIZING THE SUBMISSION OF THE APPLICATION FOR A HIGHWAY OCCUPANCY PERMIT TO ALLEGHENY COUNTY FOR THE NORTH FAYETTE BOULEVARD PROJECT.

WHEREAS, the Township of North Fayette (hereinafter "Township"), is a Municipal Corporation, duly organized and existing under the laws of the Commonwealth of Pennsylvania; and

WHEREAS, the Township is planning to construct a Township-owned roadway, known as "North Fayette Boulevard", to connect Chauvet Drive (T-892) and Cliff Mine Road; and

WHEREAS, Cliff Mine Road is owned by Allegheny County; and

WHEREAS, the Township is required to obtain a Highway Occupancy Permit from Allegheny County to permit the connection of North Fayette Boulevard to Cliff Mine Road; and

WHEREAS, the Township Engineer has prepared the application form and associated materials to submit to Allegheny County (attached as Exhibit 'A'); and

WHEREAS, the Township Engineer and the Township Manager have recommended that the attached Application for Highway Occupancy Permit form be approved by the Board of Supervisors (hereinafter "Board") and submitted, along with the required application fee, to Allegheny County for approval; and

WHEREAS, the Board has concluded that obtaining a Highway Occupancy Permit from Allegheny County is beneficial to the public.

NOW THEREFORE, BE IT RESOLVED, by the Board of Supervisors of the Township of North Fayette hereby resolves as follows, incorporating the above recitals by reference:

- SECTION 1.** The attached Application for Highway Occupancy Permit is hereby approved.
- SECTION 2.** The Chairman of the Board of Supervisors and the Township Manager are hereby authorized to execute the attached application form on behalf of the Township.
- SECTION 3.** The Township Manager is hereby authorized and directed to submit the application form, associated materials, and application fee to Allegheny County.


SECTION 4. All prior resolutions are hereby repealed in whole or in part to the extent inconsistent herewith.


SECTION 5. This Resolution shall take effect immediately.


