

## TOWNSHIP OF NORTH FAYETTE RESOLUTION NO. 35-24

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF NORTH FAYETTE, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, AUTHORIZING A CHANGE ORDER TO INCLUDE ADD ALTERNATE NO. 3 IN THE SCOPE OF WORK FOR THE CD 49 7.2 ADA CURB RAMPS, POINTE WEST PROJECT.

WHEREAS, the Township of North Fayette (hereinafter "Township"), is a Municipal Corporation, duly organized and existing under the laws of the Commonwealth of Pennsylvania; and

WHEREAS, the Township, utilizing Community Development Block Grant (hereinafter "CDBG") funding provided through the Char-West Council of Governments (hereinafter "COG") and the Allegheny County Department of Economic Development (hereinafter "ACED"), is installing curb ramps and crosswalks in the Pointe West neighborhood as part of the CD 49 7.2 ADA Curb Ramps, Pointe West Project (hereinafter "Project"); and

WHEREAS, the amount of CDBG funding available to the Township for this Project is \$46,696.00; and

**WHEREAS**, on January 23, 2024, the Board of Supervisors (hereinafter "Supervisors") awarded the contract for the Project to Fryer Excavation & Concrete in the total bid amount of \$39,170.78, as recommended for approval by the COG; and

WHEREAS, as the bid was awarded in an amount lower than the amount of grant funding available, the Township wishes to utilize the remaining grant funding, in the amount of \$7,798.22, to complete additional work in the Pointe West Neighborhood; and

**WHEREAS,** the Supervisors wish to authorize additional work, as outlined in Add Alternate No. 3 in the attached estimate received from Fryer Excavation & Concrete (Attachment "A"); and

**WHEREAS,** the Township will provide funding to cover any costs associated with additional work in excess of the amount of grant funding available.

**NOW THEREFORE, BE IT RESOLVED,** by the Board of Supervisors of the Township of North Fayette hereby resolves as follows, incorporating the above recitals by reference:

Add Alternate No. 3, in the amount of \$16,108.52 and as stated in the attached cost estimate, is hereby approved.

**SECTION 2.** The Chairman of the Board of Supervisors, the Township Manager, and/or the

Assistant Township Manager are hereby authorized to execute any necessary paperwork.

**SECTION 3.** 

All prior resolutions are hereby repealed in whole or in part to the extent

inconsistent herewith.

**SECTION 4.** 

This Resolution shall take effect immediately.
