

LOCAL LAW 1 of 2024

A local law to amend and revise certain provisions of City of Oneonta Municipal Code §236, entitled “Sewers”.

Be it enacted and ordained by the Common Council of the City of Oneonta, New York as follows:

SECTION 1: Repeal schedule of rates as set forth in §236-32 entitled “Sewer rents established, sewer rents of the City of Oneonta”.

SECTION 2: Add to §236-32 entitled “Sewer rents established, sewer rents of the City of Oneonta” the following schedule of rates:
