ORDINANCE NUMBER 2730-24

ORDINANCE AMENDING CHAPTER 523 OF THE BOROUGH CODE TO DESIGNATE A HANDICAP PARKING SPACE RESERVED FOR A SPECIFIC PERSON IN FRONT OF A CERTAIN RESIDENCE (216 GORDON STREET)

WHEREAS, the Police Department has received an application for a personalized handicap parking space pursuant to N.J.S.A. 39:4-197.7 along with the requisite \$25.00 fee; and

WHEREAS, the Mayor and Council have approved said application and the Borough Clerk has collected the additional fee of \$150.00 for same prior to adoption of the ordinance.

NOW, THEREFORE, BE IT ORDAINED, by the Borough Council of the Borough of Roselle as follows:

SECTION I. Chapter 523 “Vehicles and Traffic,” Article XII “Schedules,” Section 138B “Restricted Handicap Parking Spaces” of the Code of the Borough of Roselle is hereby amended as follows (additions in **bold**, deletions ~~struck through~~):

216 Gordon Street	West side of Gordon Street between a point 160 feet north of the northerly curblineline of Third Avenue and a point 20 feet northerly therefrom	Beverly Belvin, Placard #P2567092

SECTION II. If any section, subsection, provision, clause, or portion of this ordinance is adjudged unconstitutional or invalid by a court of competent jurisdiction, such adjudication shall not affect the remaining sections, subsections, provisions, clauses, or portions, which shall be deemed severable therefrom.

SECTION III. All ordinances or parts of ordinances inconsistent with or in conflict with this Ordinance are hereby replaced and/or repealed to the extent of such inconsistency.

SECTION IV. This Ordinance shall take effect at the time and in the manner provided by law.
