ORDINANCE NUMBER 2733-24

AN ORDINANCE TO AMEND CHAPTER 55, SECTION 26, OF THE CODE OF THE BOROUGH OF ROSELLE ENTITLED "SUMMER CAMP"

WHEREAS, pursuant to N.J.S.A. 40:48-1 et eq., the governing body of a municipality may make, amend, repeal, and enforce ordinances to manage, regulate, and control the finances and property of the municipality; and

WHEREAS, the Borough of Roselle wishes to Amend Chapter 55, Section 26, of the Ordinances of the Borough of Roselle to reflect an increase in the duration of the summer camp, and an increase of weekly fees for the same.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough of Roselle, that the Code of the Borough of Roselle, Chapter 55, Section 26, entitled "Summer camp", subsections A and B are hereby amended as follows (additions in **bold**; deletions ~~struck through~~):

SECTION I.

§ 55-26. Summer camp.

There shall be hereby fixes and established fees chargeable to participants by the Borough for **an eight (8) week** summer camp as stated below:

A. Roselle resident:

Number of Children	Fee
1 child	\$360 504 for summer (\$60 63 per week)
2 children	\$330 464 for summer (\$55 58 per week) per child
3 or more children	\$300 424 for summer (\$50 53 per week) per child

B. Nonresident: ~~\$750~~**1040** (~~\$125~~**130** per week).

SECTION II. If any section, subsection, provision, clause, or portion of this ordinance is adjudged unconstitutional or invalid by a court of competent jurisdiction, such adjudication shall not affect the remaining sections, subsections, provisions, clauses, or portions, which shall be deemed severable therefore.

SECTION III. All ordinances or parts of ordinances inconsistent with or in conflict with this Ordinance are hereby replaced and/or repealed to the extent of such inconsistency.

SECTION IV. This Ordinance shall take effect at the time and in the manner provided by law.
