ORDINANCE AMENDING CHAPTER 523 OF THE BOROUGH CODE TO DESIGNATE A HANDICAP PARKING SPACE RESERVED FOR A SPECIFIC PERSON IN FRONT OF A CERTAIN RESIDENCE (612 EAST 3RD AVENUE)

WHEREAS, the Police Department has received an application for a personalized handicap parking space pursuant to N.J.S.A. 39:4-197.7 along with the requisite \$25.00 fee; and

WHEREAS, the Mayor and Council have approved said application and the Borough Clerk has collected the additional fee of \$150.00 for same prior to adoption of the ordinance.

NOW, THEREFORE, BE IT ORDAINED, by the Borough Council of the Borough of Roselle as follows:

SECTION I. Chapter 523 "Vehicles and Traffic," Article XII "Schedules," Section 138B "Restricted Handicap Parking Spaces" of the Code of the Borough of Roselle is hereby amended as follows (additions in **bold**, deletions struck through):

SECTION IV. This Ordinance shall take effect at the time and in the manner provided by law.
