**LOCAL LAW 2023-11, A LOCAL LAW AMENDING THE
ZONING MAP OF THE TOWN OF SALINA:**

**Be it enacted by the Town Board of the Town of Salina, Onondaga County,
New York as follows:**

Section 1. The Zoning District of the following property located 3700 Court Street, Town of Salina, County of Onondaga, State of New York is hereby changed from C-2 Highway Commercial District to C-2 Highway Commercial with OL-1 Motor Vehicles Service Facilities Overlay District:

Tax Parcel – 068.-06-01.1

Section 2. The Zoning Map of the Town of Salina is hereby amended to reflect the change of Zoning Districts as authorized above.

Section 3. This Local Law shall take effect upon the filing thereof with the Secretary of State of the State of New York.

WHEREAS, on August 28, 2023, the Town Board held a public hearing regarding the proposed Local Law and no one spoke against said Local Law.

NOW, THEREFORE, BE IT

RESOLVED, that Local Law 2023-11 is hereby approved and enacted; and be it further

RESOLVED, that the Town Clerk is directed to file Local Law 2023-11 with the Secretary of State within 20 days of the date set forth herein.
