## CITY OF SALEM ORDINANCE 24-12

## AN ORDINANCE AMENDING CHAPTER 153 OF THE CODE OF THE CITY OF SALEM, NEW JERSEY TO REGULATE WILD ANIMAL FEEDING IN PARKS AND RECREATION AREAS

WHERAS, pursuant to N.J.S.A. 40:48-2, the Mayor and City Council are authorized to enact and amend ordinances as deemed necessary for the preservation of the public health, safety and welfare and as may be necessary to carry into effect the power and duties conferred and imposed upon the City by law; and

WHEREAS, the revised stormwater regulations require the City to adopt regulations on wildlife feeding in parks and recreation areas; and

WHEREAS, it is the intent of the City to amend Chapter 153 of the Salem Code to conform to the new stormwater regulations; and

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SALEM:

Section 1. Chapter 153-9 Animals is hereby amended as follows:

Current §153-9 Animals is deleted in its entirety and replaced with the following.

"§153-9 Animals.

- A. No person shall molest, trap, capture, hold, remove, injure or kill any animal or disturb its habitat within a city park or recreation area.
- B. No person shall feed, in any public park or on any other property owned or operated by the City, any wild animal. Exemptions include unconfined wildlife at environmental education centers and feral cats as part of an approved Trap-Neuter-Release program."
