CITY OF SALEM ORDINANCE 24-11

AN ORDINANCE AMENDING CHAPTER 185, ARTICLE II OF THE CODE OF THE CITY OF SALEM, NEW JERSEY FOR THE PURPOSE OF ESTABLISHING PROPER MANAGEMENT OF RESIDENTIAL YARD WASTE

WHERAS, pursuant to N.J.S.A. 40:48-2, the Mayor and City Council are authorized to enact and amend ordinances as deemed necessary for the preservation of the public health, safety and welfare and as may be necessary to carry into effect the power and duties conferred and imposed upon the City by law; and

WHEREAS, the revised stormwater regulations require the City to adopt regulations on the proper management of residential yard waste; and

WHEREAS, it is the intent of the City to amend Chapter 185, Article II of the Salem Code to conform to the new stormwater regulations; and

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SALEM:

Section 1. Chapter 185, Article II entitled "Garbage and Trash" is hereby amended as follows:

The below subparagraph C is added to current §185-11 Prohibited Acts as follows:

"C. No personal shall sweep, rake, blow, or otherwise place yard waste into the street unless it is for a scheduled collection. For non-containerized (loose) yard waste scheduled collection, place of loose yard wase must be at least 10 feet away from and storm drain inlet and no sooner than 7 day prior to a scheduled and announced collection."
