	DING AND SUPPLEMENTING SECTION 150-3 OF THE RELATING TO PENALTIES FOR ILLEGAL DUMPING

WHEREAS, the City Council of the City of Trenton has determined it in the best interests of the City to increase the penalties for illegal Dumping as defined in Trenton City Code Chapter 150-1 et seq.;

NOW IT IS HEREBY ORDAINED, by the City Council of the City of Trenton that the provisions of Section 150-3B of the Trenton City Code be and are hereby amended and supplemented to read as follows:

[150-13 Violations and Penalties (Repealed)

B. Any person who violates the provisions of this Chapter with respect to Dumping shall be subject to a fine of \$2,500.00 for a first offense and, for a subsequent offense, to a fine not exceeding \$10,000.00 pursuant to N.J.S.A. 4:49-5.]

150-13 Violations and Penalties (New)

B. Any person who violates the provisions of this Chapter with respect to Dumping shall be subject to a fine of \$2500. for a first offense. For a second or subsequent offense, a fine not to exceed \$10,000., and/or 90 days imprisonment; and/or 90 days of Community Service may be imposed in the discretion of the Court. The Court may further order the violator to bear the actual costs of clean up, if applicable.

IT IS FURTHER ORDAINED, that any Ordinances or parts thereof which are inconsistent with the provisions of this Ordinance be and hereby are repealed to the extent of such inconsistency;

IT IS FURTHER ORDAINED, that in the event any portion of this Ordinance is declared invalid, the remaining portions hereof shall remain in full force and effect;

IT IS FURTHER ORDAINED, that this Ordinance shall take effect pursuant to NJSA 40:69A-181 and other applicable law.
