

AN ORDINANCE ESTABLISHING THE OFFENSE OF MISCELLANEOUS HEALTH AND SAFETY BY THE ADDITION OF SECTION 210.510 TITLE IV OFFENSES CONCERNING PUBLIC SAFETY AND THE ADDITION OF THE DEFINITION OF 'HEALTH' AND 'SAFETY' UNDER SECTION 210.010 TITLE I OF THE MUNICIPAL CODE OF THE CITY OF VALLEY PARK, MISSOURI

WHEREAS, to further protect the health, safety, and welfare of the City of Valley Park's residents and guests; and

WHEREAS, the Board of Aldermen of the City of Valley Park cannot anticipate every act or attempted act that may endanger another person's health and safety and this provision is intended to prohibit reckless conduct undertaken without regard for the health and safety of members of the public; and

WHEREAS, after being discussed, debated, and recommended by the Legislative Committee for the City of Valley Park.

NOW, THEREFORE, BE IT ORDAINED by the Board of Aldermen of the City of Valley Park, Missouri as follows:

Section One: A new Section numbered 210.510 shall be added to Article IV of the Municipal Code of the City of Valley Park making it an ordinance violation to commit 'Miscellaneous Health & Safety' as follows:

Section 210.510 Miscellaneous Health & Safety

A person commits the offense of miscellaneous health & safety if he/she does or causes any action that endangers or potentially dangers the health and safety of another person. A person who violates this provision is subject to the penalties pursuant to Sec. 100.220 of this Code.

Section Two: Section 210.010 of the Municipal Code of the City of Valley Park, Missouri is hereby amended to add the definitions of 'health' and 'safety' as follows:

HEALTH

A person's mental or physical condition and the state of complete physical, mental, and social well-being.

SAFETY

The condition of being protected from or unlikely to cause danger, risk, or injury.

Section Three: It is hereby declared to be the intention of the Board of Aldermen that each and every part, section, and subsection of this ordinance shall be separate and severable from each and every other part, section, and subsection hereof and that the Board of Aldermen intends to adopt each said part, section, and subsection separately and

independently of any other part, section, and subsection. In the event that any part of this ordinance shall be determined to be or to have been unlawful or unconstitutional, the remaining parts, sections, and subsections shall be and remain in full force and effect.

Section Four: This ordinance shall take full effect and be in full force upon its passage by the Board of Aldermen and Approval of the Mayor of the City of Valley Park.
