A local law Amending Chapter 31 of the Town Code Regarding Residency of the Court Clerk for the

of Wheatland as follows:

A person may not hold the office of Court Clerk for the Town of Wheatland unless such person is a citizen of the United States and a resident of the State of New York, the County of Monroe or an adjoining or contiguous county. A person may hold the office of Court Clerk for the Town of Wheatland whether or not such person is a resident of the Town of Wheatland and/or an elector of the Town of Wheatland. The provision of this article stating that a person may hold the office of Court Clerk whether or not such person is a resident of the Town of Wheatland and/or an elector of the Town of Wheatland shall supersede the requirements of local residency set forth in §3, Subdivision 1, of the Public Officers Law of the State of New York and shall also supersede the requirement of being a local elector set forth in §23, Subdivision 1, or the Town Law of the State of New York.


