ORDINANCE NO. 2019-08

ORDINANCE OF THE BOROUGH OF WRIGHTSTOWN AUTHORIZING THE EXECUTION OF A LEASE FROM THE WRIGHTSTOWN MUNICIPAL UTILITIES AUTHORITY FOR PART OF THE PROPERTY KNOWN AS BLOCK 501, LOT 18

WHEREAS, the Wrightstown Municipal Utilities Authority ("MUA") is the owner of certain real property consisting of approximately 7.82 acres and identified as Block 501, Lot 18 on the official tax map of the Borough of Wrightstown, together with all appurtenances, fixtures, improvements, buildings, and structures thereon (collectively the "Property"); and

WHEREAS, the Borough of Wrightstown ("Borough") operates and maintains a maintenance facility (the "Maintenance Facility") and a recycling center (the "Recycling Center") on part of the Property; and

WHEREAS, the MUA conducts certain business operations on various other portions of the Property; and

WHEREAS, the Borough wishes to lease from the MUA and the MUA wishes to lease to the Borough, those portions of the Property which enable the Borough to continue operating the Maintenance Facility and Recycling Center; and

WHEREAS, the operation of the Maintenance Facility and the Recycling Center is a public purpose; and

WHEREAS, pursuant to N.J.S.A. 40A:12-15, the Borough may to enter into a leasehold for a public purpose for up to fifty (50) years;

NOW, THEREFORE, BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF WRIGHTSTOWN, IN THE COUNTY OF BURLINGTON, STATE OF NEW JERSEY AS FOLLOWS:

<u>Section One:</u> The Mayor and Borough Clerk, and such other Borough officials and employees as may prove necessary, are hereby authorized and directed to execute a lease with the MUA for part of the Property in a form approved by the Borough Solicitor that is substantially similar to

the form attached hereto as Exhibit "A" for the purpose of operating the Maintenance Facility

and Recycling Center, or for such other public purpose as may become necessary.

Section Two: Severability. If any sentence, paragraph or section of this Ordinance, or the

application thereof to any persons or circumstances shall be adjudged by a court of competent

jurisdiction to be invalid, or if by legislative action any sentence, paragraph or section of this

Ordinance shall lose its force and effect, such judgment or action shall not affect, impair or void

the remainder of this Ordinance.

Section Three: Effective Date. This Ordinance shall become effective immediately upon final

passage and publication in accordance with the law.

Section Four: Repealer. All other Ordinances or parts of Ordinances inconsistent herewith are

hereby repealed to the extent of such inconsistency.
