ORDINANCE 2018-08**

**AN ORDINANCE AUTHORIZING AN EMERGENCY APPROPRIATION
PURSUANT TO N.J.S.A. 40A:4-53 FOR CODIFICATION OF
ORDINANCES IN THE BOROUGH OF WRIGHTSTOWN**

BE IT ORDAINED by the Borough Council of the Borough of Wrightstown, County of Burlington, State of New Jersey, (not less than two-thirds of all members thereof affirmatively concurring), as follows:

BE IT FURTHER ORDAINED, that pursuant to N.J.S.A. 40A:4-53 (Chapter 48, PL 1956 as amended by Chapter 144, PL 1965 and Chapter 38, PL 1969) the sum of \$6,000.00 is hereby appropriated for the preparation of a codification of ordinances and shall be deemed a special emergency appropriation as defined and provided for in N.J.S.A. 40A:4-55.

BE IT FURTHER ORDAINED the authorization to finance the appropriation shall be provided for in succeeding annual budgets by the inclusion of at least one-fifth authorized pursuant to the act (N.J.S.A. 40A:4-55).

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon the passage and publication according to law.
