**ORDINANCE 2022-03**

**AN ORDINANCE TO AMEND ORDINANCE 2020-07 TO PROVIDE FOR AND DETERMINE THE RATE OF COMPENSATION, SALARY OR WAGE OF CERTAIN OFFICERS, APPOINTEES AND EMPLOYEES OF THE BOROUGH OF WRIGHTSTOWN, IN THE COUNTY OF BURLINGTON, STATE OF NEW JERSEY AND REGULATING THE MANNER OF PAYMENT OF SAME**

**BE IT ORDAINED AND ENACTED** by the Borough Council of the Borough of Wrightstown, County of Burlington, State of New Jersey, as follows:

**Section 1.** The annual rate of compensation, salary and wages of the following officers, appointees and employees of the Borough of Wrightstown is hereby fixed in the following schedule:
