## WRIGHTSTOWN BOROUGH

ORDINANCE 2010-01
AN ORDINANCE OF THE BOROUGH OF WRIGHTSTOWN
AMENDING THE PATRIOTS WALK REDEVELOPMENT OVERLAY ZONING

BE IT ORDAINED AND ENACTED, by the Borough Code of the Borough of
Wrightstown, County of Burlington and State New Jersey as follows:

## Section 1.

The Patriots Walk Overlay Zoning adopted by Borough Ordinance 2009-03 adopted June 10,2009 shall be and is hereby amended in accordance with the recommendations provided by the Borough Planner as attached hereto.

## Section 2. Severability.

If any section, subsection, paragraph, sentence or other part of this Ordinance is adjudged unconstitutional or invalid, such judgment shall not affect or invalidate the remainder of this Ordinance, but shall be confined in its effect to the section, subsection, paragraph, sentence or other part of this Ordinance directly involved in the controversy in which said judgment shall have been rendered and all other provisions of this Ordinance shall remain in full force and effect.

## Section 3. Inconsistent Ordinances Repealed.

All ordinances or parts of ordinances which are inconsistent with the provisions of this ordinance are hereby repealed, but only to the extent of such inconsistencies.

## Section 4. Effective Date.

This Ordinance shall take effect immediately upon final adoption and publication in the manner prescribed by law.

# PATRIOT'S WALK OVERLAY ZONING REDEVELOPEMNT PHASE ONE Mixed Use District Redevelopment Area ~ Phase One Adopted June 10, 2009 

Amendments Thereto:
Sections I through IV
Are 'Required Standards'
Section III A.2. - Omit sentence.
"This is intended to allow for one way parking aisle with full pavement treatment in front of the buildings along Fort Dix Street."

## Section III E.1.a.

- Add
"Predominately means in excess of fifty percent in a pattern acceptable to the Board."
Section IV B.
Each building is defined at each 60 feet of façade front area, whether united as one building or a group of buildings.
Section IV G.5. - Add
Add after "following": "consistent with the rendering submitted by the Redeveloper".
Section IV G.12.
Modify to read: Architectural elevations shall be substantially similar to the rendering provided
by the Redeveloper in Sketches 3 and 5.


## Section IV H.6.

Cementations siding or trim with wood grain is limited to five (5\%) percent of the front elevation, ten (10\%) percent of the side elevations and twenty-five (25\%) percent of the rear elevations.
Section IV F.4.
The minimum height of a front façade on Fort Dix Street and Patriot's Walk shall be two stories.

## Section IV I. 3.a.

Boxed out glass display areas on the first floor level shall occur every seventy-five (75') feet with a minimum width of sixteen (16') feet.
