ORDINANCE NO. 2013-02

**AN ORDINANCE AUTHORIZING AND APPROVING
ACQUISITION OF REAL PROPERTY**

WHEREAS, the Borough Council of the Borough of Wrightstown has been offered certain property for use as for a public purpose at no cost; and

WHEREAS, the Borough Council of the Borough of Wrightstown has determined that it is appropriate and desirable to acquire such property for this purpose; and

WHEREAS, a form of contract for the acquisition of the property is annexed hereto;

NOW THEREFORE BE IT ORDAINED AND ESTABLISHED, by the Borough Council of the Borough of Wrightstown in the County of Burlington and State of New Jersey that the Borough acquire Block 302, Lots 3 & 4, consisting of approximately 0.73 acres from Pirkko McNabb for the nominal consideration of One Dollar (\$1.00) pursuant to a contract substantially the same as the form annexed hereto as may be modified subject to the review and approval of the Borough Solicitor;

AND BE IT FURTHER ORDAINED AND ESTABLISHED that the Mayor and/or Clerk are hereby authorized to take such actions and execute such documents as are necessary to carry out the intent and purpose of this ordinance.
