

**TOWNSHIP OF HAMILTON  
ORDINANCE NO.: 1835**

**AN ORDINANCE AMENDING EXHIBIT A, SECTION 1  
ARTICLE II OF CHAPTER 66 OF THE CODE OF THE  
TOWNSHIP OF HAMILTON, PROVIDING FOR THE  
MAXIMUM NUMBER OF EMPLOYEES**

**WHEREAS**, the Township Committee has determined that it is in the best interest of the Township to add three additional Police Officer positions; and

**WHEREAS**, partial funding will come from a grant and the balance will be funded in the operating budget; and

**WHEREAS**, the Township has entered into a shared services agreement with Buena Vista Township to provide Municipal Court Services; and

**WHEREAS**, the Township has determined that it needs to hire two additional Violation Clerks to complete the additional and existing work in the Municipal Court;

**NOW THEREFORE BE IT HEREBY ORDAINED** by the Township Committee of the Township of Hamilton, County of Atlantic, State of New Jersey, that Article II of Chapter 66 of the Township Code, titled Personnel, shall be amended as follows:

**SECTION 1. Create Position**

Amend the Staffing Chart to include three (3) additional police officer positions:

**SECTION 2. Create Position**

Amend the Staffing Chart to include two (2) additional violation clerk positions:

**SECTION 3. Delete Position**

Amend the Staffing Chart by deleting one part-time violations clerk.

**SECTION 4. Severability and Effectiveness Clause.**

- (a) If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional, invalid, or unenforceable by a court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.
- (b) Any Ordinance inconsistent with the terms of this Ordinance is hereby repealed to the extent of such inconsistency.

**SECTION 5. Effective Date.**

This Ordinance shall take effect immediately upon final passage and publication as provided by in law.
