ORDINANCE 15-2021

AN ORDINANCE DEDICATING TO THE COUNTY, FOR PUBLIC USE, AN EASEMENT OF RIGHT OF WAY, ACROSS AND THROUGH LAND IN THE CITY OF ABSECON, IDENTIFIED ON THE MUNICIPAL TAX MAP AS BLOCK 229, P/O LOTS 1 AND 2

WHEREAS, that the County of Atlantic owns and maintains Mill Road (CR 651). The County has developed plans to undertake a roadway resurfacing project along Mill Road adjacent to the Grantor's property at Block 229, Lots 1 and 2 in the City of Absecon. Accordingly, it is in the interest of the County of Atlantic and for the welfare of the general public that the lands hereinafter described, shall be burdened with an easement of right of way for the purpose of constructing, improving, operating and maintaining a public road, public right of way, and related improvements upon and across such land, as illustrated on the attached parcel maps and descriptions as follows:

Exhibit A: Parcel Maps and Descriptions for two areas within Block 229, Lot 1 totaling 10,950 square feet

Exhibit B: Parcel Map and Description for an area within Block 229, Lot 2

totaling 630 square feet

NOW, THEREFORE, in consideration of a payment in the sum of ONE DOLLAR (\$1.00) paid by the County to the Grantor, the receipt of which the Grantor hereby acknowledges, the Grantor does hereby dedicate to the County, for public use, an easement of right of way for the purposes described herein, across and through the following land in the City of Absecon, identified on the municipal tax map as Block 229, p/o Lots 1 and 2, and being described on the attached Exhibit A and Exhibit B for the purposes set forth herein:

CONTAINING A TOTAL AREA OF 11,580 SQUARE FEET (0.26 acres)

TOGETHER WITH the right and permission to resurface the roadway, perform topographic grading, top soiling and seeding within the Right of Way Easement area as shown on the aforesaid map, together with the right to trim or remove trees, stumps and other vegetation, along with the right to construct and maintain drainage facilities, erosion control facilities and appurtenances, including the right to construct and maintain fencing, guiderails and slopes as the County Engineer may deem reasonably necessary to accommodate the County's improvements.







RIGHT OF WAY EASEMENT
