## **ORDINANCE 10-2011**

AN ORDINANCE AMENDING THE CODE OF THE CITY OF ABSECON, CHAPTER 330, VEHICLES AND TRAFFIC, ADDING SCHEDULE XXII, SECTION 330-51 FIREHOUSE PARKING LOTS AND AMENDING VARIOUS SCHEDULES WITHIN CHAPTER 330.

NOW THEREFORE, BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE CITY OF ABSECON CITY, NEW JERSEY that Chapter 330, be amended by adding with the following:

## SECTION 330-51. Schedule XXII: Firehouse Parking Lots:

On all parking lots and driveways surrounding the Absecon Firehouse located on Block 203 Lot 1.02, parking is restricted to vehicles authorized by the Chief of the Absecon Fire Department. Such authorization shall be in the form of verbal authorization from the Chief of the Fire Department.

**BE IT FURTHER ORDAINED THAT**: Section 330-30, Schedule II is amended to remove all reference to New Jersey Ave. Section 330-31, Schedule III is amended to remove all references to New Jersey Ave. Section 330-39, Schedule X is amended to remove all references to New Jersey Ave.

**BE IT FURTHER ORDAINED THAT**: Section 330-32, Schedule IV Time Limit Parking: is amended as follows: Two hour parking on the south side of New Jersey Avenue from a point 80 feet west of the centerline of Station Avenue to a point 428 feet west of the centerline of Station Avenue.

Two hour parking on the north side of New Jersey Avenue from a point 71 feet east of the centerline of Mechanic Street to a point 280 feet east of the centerline of Mechanic Street

Two hour parking on the north side of New Jersey Avenue from a point 71 feet west of the centerline of School Street to a point 369 feet west of the centerline of School Street

Two hour parking on the north side of New Jersey Avenue from a point 82 feet east of the centerline of Wyoming Avenue to a point 364 feet east of the centerline of Wyoming Avenue

Two hour parking on the north side of New Jersey Avenue from a point 65 feet west of the centerline of Wyoming Avenue to a point 384 feet west of the centerline of Wyoming Avenue.

BE IT FURTHER ORDAINED THAT: Section 330-29, Schedule I No Parking: is amended as follows:

No parking on the north side of New Jersey Avenue from Station Avenue to a point 280 feet east of the centerline of Mechanic Street

No parking on the north side of New Jersey Avenue from a point 71 feet east of the centerline of Mechanic Street to a point 71 feet west of the centerline of School Street

No parking on the north side of New Jersey Avenue from a point 369 feet west of the centerline of School Street to a point 364 feet east of the centerline of Wyoming Avenue

No parking on the north side of New Jersey Avenue from a point 82 feet east of the centerline of Wyoming Avenue to a point 65 feet west of the centerline of Wyoming Avenue

No parking on the north side of New Jersey Avenue from New Road to a point 384 feet west of the centerline of Wyoming Avenue

No parking on the south side of New Jersey Avenue from Station Avenue to a point 80 feet west of the centerline of Station Avenue

No parking on the south side of New Jersey Avenue from a point 428 feet west of the centerline of Station Avenue to New Road

## **BE IT FURTHER ORDAINED** that:

- 1. Any Ordinance or parts of ordinances, which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of any such inconsistency.
- 2. This ordinance shall take effect upon final adoption and publication as required by Law.
