ORDINANCE NO. 2018-02

**AN ORDINANCE OF ALEPPO TOWNSHIP PROVIDING
A REVISED SCHEDULE OF RATES FOR SEWAGE SERVICE TO ALEPPO
TOWNSHIP AUTHORITY CUSTOMERS**

WHEREAS, a complete Schedule of Rates is presently in effect in the Township of Aleppo (the "Township") for billing water and sewage services provided by the Aleppo Township Authority (the "Authority"); and


WHEREAS, the Authority has fully discussed and considered the recent costs of construction, debt service, operations, treatment and other allowable expenses including replacement costs incurred as a result of the completed sanitary sewer project, which was designed to provide public sewerage to the vast majority of residents in the Authority's service area, the other requirements of its system, and the recommendations for new rates as presented by the Authority's Consulting Engineer ("Bankson"); and

WHEREAS, following results of a recently performed study by Bankson, which included a review of the treatment rates charged by the Borough of Sewickley, the Authority has determined that it is now necessary and desirable to alter and revise its existing rate structure for the provision of sanitary sewerage service in order to continue to provide quality service to its customers;

NOW, THEREFORE, in recognition and in consideration of the foregoing, and upon recommendation by the Authority's consulting engineer, be it hereby ordained by the Aleppo Township Board of Commissioners, by action passed at its regular monthly meeting held on January 15, 2018 that effective January 1, 2018 the current rates for providing sewage service be and the same are hereby revised in accordance with the attached Exhibit A, the terms of which are incorporated herein.

1. Ordained and enacted into law this 15th day of January, 2018.
2. All ordinances previously adopted and enacted that are inconsistent with this Ordinance are hereby rescinded and repealed, effective upon the date of adoption.


