ORDINANCE NO. 2023-04

**AN ORDINANCE OF THE TOWNSHIP OF ALLEN,
NORTHAMPTON COUNTY, PENNSYLVANIA,
AMENDING THE CODE OF THE TOWNSHIP OF
ALLEN BY AMENDING CHAPTER 15, PART 2, SECTION
15-213, (STOP INTERSECTIONS ESTABLISHED), TO
CREATE THREE-WAY STOP INTERSECTIONS AT
ATLAS ROAD AND PHYLLESE DRIVE**

WHEREAS, the Allen Township Board of Supervisors adopted the Code of the Township of Allen on November 8, 2007; and

WHEREAS, Article XXIII of the Second Class Township Code authorizes the Board of Supervisors to provide for the installation of traffic signals and devices, to regulate parking, and to create one-way streets; and

WHEREAS, the Allen Township Board of Supervisors now desires to amend the Code to create three-way stop intersection at Atlas Road and Phyllese Drive; and

WHEREAS, the Township has complied with all applicable pre-requisites and/or requirements under the law, including the applicable traffic studies, with regard to the installation of traffic signals and devices; and

WHEREAS, the adoption of this Ordinance is intended to promote the public health, safety, comfort, convenience, and general welfare of the citizens of Allen Township and the traveling public.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the Board of Supervisors of Allen Township that the Code of the Township of Allen be and is hereby amended as follows:

SECTION 1. CHAPTER 15, PART 2, SECTION 15-213 is hereby amended by adding additional intersections to Subsection 1 as follows:

15-213 Stop Intersections Established

| Stop Street | Intersection or Through Street | Direction of Travel |
|--------------------|---------------------------------------|----------------------------|
| Atlas Road | Phyllese Drive | East |
| Atlas Road | Phyllese Drive | West |
| Phyllese Drive | Atlas Road | North |

SECTION 2. The penalties provided for in Chapter 15 of the Code of the Township of Allen shall be applicable to the provisions of this Ordinance.

SECTION 3. If any provision, sentence, clause or part of this ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality, or invalidity shall not affect or impair any of the remaining provisions of this Ordinance. It is hereby declared as the intent of Allen Township that this Ordinance would have been adopted had such stricken provisions not been included herein.

SECTION 4. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SECTION 5. This Ordinance shall become effective five (5) days after adoption thereof.
