Council Members MARSHALL, RANDOLPH, SHABAZZ & WEEKES Present the following Ordinance:

## ORDINANCE TO AMEND THE ATLANTIC CITY CODE CHAPTER 210 REGULATING ROLLING CHAIRS.

WHEREAS, Chapter 210 of the Code of the City of Atlantic City establishes the regulations under which rolling chairs are permitted to operate; and

WHEREAS, certain sections of Chapter 210 require revisions to effectuate the licensing and continued safe operation of the rolling chairs; and

WHEREAS, due to increased administrative costs, rolling chair fees must be adjusted;

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Atlantic City that the following City Code Sections shall be amended as described below showing the deleted sections with a line through them and the replacement or added language underlined:

## Section 1. Section 210-4. Rates

- A. The rate to be charged for hire of a rolling chair for one or two persons shall be:
  - (1) Zero to five blocks: \$5 \$10.
  - (2) Six to 12 ten blocks: \$10 \$15.
  - (3) Thirteen to 21 blocks Eleven to fifteen blocks: \$15 \$20.
  - (4) Twenty-two to 32 blocks: \$20. Sixteen blocks and above: \$1 per block.
  - (5) Half-hour tour: \$25 \$30 \$40.
  - (6) One-hour tour: \$40 \$50 \$60.
- B. The rate to be charged for a third person shall be an additional charge of:\$5
  - (1) Zero to 12 blocks: \$3.
  - (2) Thirteen to 32 blocks: \$5.
  - (3) Tour: \$5

<u>Section 2.</u> All ordinances or parts of ordinances inconsistent with the provisions of this ordinance are hereby repealed to the extent necessary to remedy the inconsistency.

Section 3. This Ordinance shall become effective upon final passage and publication as provided by law.
