Council Member <u>SHABAZZ</u> Presents the following Ordinance:

ORDINANCE TO AMEND CITY CODE CHAPTER 243 REGULATING PARKING ON GREEN ACRES PARKLAND

WHEREAS, there exists funded parkland within the City of Atlantic City; and

WHEREAS, this funded parkland is inspected by the Department of Environmental Protection every three years to ensure compliance with the terms of any project agreement(s), Title 7 of the New Jersey Administrative Code, and other applicable Green Acres laws; and

WHEREAS, parking on funded Green Acres land may only be used for conservation and recreational purposes; and

WHEREAS, City Council desires to regulate parking on funded parkland to ensure compliance with Green Acres laws.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Atlantic City that Chapter 243, which regulates Vehicles and Traffic, Article VIII shall be amended as follows:

SECTION 1.

Chapter 243-85. Schedule XXVII: Parking on Green Acres funded parkland.

Parking or standing a vehicle on funded parkland is subject to Green Acres laws and shall only be permitted for conservation and recreational uses.

Violators of this ordinance shall be subject to violations and penalties as outlined in Chapter 243-3.

SECTION 2. Any Ordinance or parts of any Ordinance inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 3. This Ordinance shall take effect upon its final passage and publication according to law. However, no penalty for violation of this Ordinance with respect parking on funded parkland shall be enforced, until a period of 30 days has elapsed from the time signs giving notice of the parking restriction imposed by this Ordinance have been posted on funded parkland.
