

ATLANTIC COUNTY ORDINANCE NO. 11 - 2023

**ORDINANCE CHANGING THE TERM OF OFFICE FOR APPOINTEES TO THE
POLICE TRAINING ADVISORY BOARD**

WHEREAS, the Police Training Advisory Board is established in subsection L of section 4-64.10 of the Atlantic County Code (the Code); and

WHEREAS, the language of paragraph one (1) provides for six members, each of which shall be appointed for staggered three-year terms; and

WHEREAS, the County's Director of Public Safety deems it advisable to change the term of office to one year in order to better accommodate changes in positions in various law enforcement agencies throughout the County; and

WHEREAS, in order to effectuate said change it is necessary to amend the provisions to the County Code which deal with the Police Training Advisory Board.


NOW, THEREFORE, be it ordained that the Atlantic County Board of County Commissioners does hereby amend paragraph 1 of subsection L of section 4-64.10 of the Atlantic County Code, the provisions of which shall be amended by deleting the current language which shall be replaced with the following language:

~~Membership shall consist of six (6) members, five (5) of whom are also members of the Atlantic County Chiefs of Police Association, who shall be nominated by the President of the Atlantic County Chiefs of Police Association, and one (1) of whom shall be a representative of county government. Each member shall be appointed for staggered terms of three (3) years commencing May 1. Of those first appointed, two (2) shall serve for a term of two (2) years, and two (2) shall serve for a term of three (3) years; and~~

Membership shall consist of six (6) members, five (5) of whom are also members of the Atlantic County Chiefs of Police Association, who shall be nominated by the President of the Atlantic County Chiefs of Police Association, and one (1) of whom shall be a representative of county government. All members shall be appointed to serve a one (1) year term to expire June 30th of each year.


This change in the term of the appointment shall apply only to appointees who commence their term of office in calendar year 2024 and in subsequent calendar years.


