

ORDINANCE NO. 2023-6

**AN ORDINANCE OF THE TOWNSHIP OF BARNEGAT,
COUNTY OF OCEAN STATE OF NEW JERSEY
AMENDING AND SUPPLEMENTING CHAPTER 50,
CHAPTER 56, CHAPTER 57, CHAPTER 76,
CHAPTER 77 AND CHAPTER 81**

NOW THEREFORE BE IT ORDAINED by the Mayor and Township Committee of the Township of Barnegat, County of Ocean, and State of New Jersey that certain sections of Chapter 50, Chapter 56, Chapter 57, Chapter 76, Chapter 77 and Chapter 81 of the Township Code are hereby amended as follows:

SECTION 1. Chapter 50 of the Township Code entitled “Charitable Clothing Bins” and specifically §50-3 thereof entitled “Permit Fee”; is hereby amended and supplemented to read as follows:

The annual permit fee is fifty dollar (\$50.) per bin and will be used to offset the costs involved in enforcing this chapter. All licenses shall expire on December 31 of the year in which they were issued.

SECTION 2. Chapter 57 of the Township Code entitled “Motor Vehicle Junk Dealers” and specifically §57-11 thereof entitled “License fees; expiration” is hereby amended and supplemented to read as follows:

The fee for license required by this ordinance shall be \$100.00 per year. Such license shall expire on the 1st day of January of following year in which license was issued.

SECTION 3. Chapter 56 of the Township of the Township Code entitled “Mobile Home Parks” and specifically §56-11 thereof entitled “Operation; fees” is hereby amended and supplemented to read as follows:

- B. *License and registration fee. Every person, firm or corporation obtaining a license as hereinabove provided shall pay to the Township of Barnegat a license fee of five hundred (500.00) dollars*

SECTION 5. Chapter 77 of the Township Code entitled “Laundries, Self-Service” and specifically §77-6 entitled “License requirements” is hereby amended and supplemented to read as follows:

SECTION 6. Chapter 81 of the Township Code entitled “Swimming Pools” and specifically §81-5 thereof entitled “Fees” is hereby amended and supplemented to read as follows:

The following fees and charges are herewith established.

- A. *For the issuance or renewal of a license to operate a swimming pool: one hundred (\$100.00) dollars. All licenses shall expire on December 31 of the year in which they were issued.*

SECTION 7. If any section, subsection, paragraph, sentence or other part of this Ordinance is adjudged unconstitutional or invalid, such judgment shall not affect or invalidate the remainder of this Ordinance but shall be confined in its effect to the section, subsection, paragraph, sentence or other part of this Ordinance directly involved in the controversy in which said judgment shall have been rendered and all other provisions of this Ordinance shall remain in full force and effect.

SECTION 8. All Ordinances or parts of Ordinances which are inconsistent with the provisions of this Ordinance are hereby repealed, but only to the extent of such inconsistencies.

SECTION 9. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.
