ORDINANCE NO. 2024-733
(Duly Adopted February 12, 2024)

**AN ORDINANCE SPECIFYING A HANDICAPPED
PARKING ZONE AT 149 Washington St.**

WHEREAS, the Borough Council of the Borough of Bath has determined that it is appropriate to create certain handicapped parking zones for individuals with physical infirmities unable to park in other locations, and to provide for the greater convenience of such individuals; and

WHEREAS, one such parking space is required at 149 Washington Street in the Borough of Bath.

NOW, THEREFORE, BE IT AND IT IS HEREBY ORDAINED by the Borough Council of the Borough of Bath as follows:

1. Handicapped Parking. No person shall park a vehicle, or allow the same to remain parked, in any of the following locations unless such person is handicapped, and is operating a vehicle which bears handicapped parking plates:

2. Penalty for Violation.




