

ORDINANCE ANNEXING CERTAIN ADJACENT TERRITORY INTO THE CITY OF BONNE TERRE, MISSOURI

WHEREAS, on Monday, November 5, 2018, a verified petition signed by all the owners of the real estate hereinafter described requesting annexation of said territory into the City of Bonne Terre, Missouri, was filed with the city clerk; and

WHEREAS, said real estate as hereinafter described is adjacent and contiguous to the present corporate limits of the City of Bonne Terre, Missouri; and

WHEREAS, a public hearing concerning said matter was held at the City Hall in Bonne Terre, Missouri, at the hour of 5:45 p.m. on Monday, November 19, 2018; and

WHEREAS, notice of said Public Hearing was given by publication of notice thereof, on Friday, October 26, 2018, Friday, November 2, 2018, and Friday, November 9, 2018 in the Daily Journal a weekly newspaper of general circulation in the County of St. Francois, State of Missouri; and

WHEREAS, at said Public Hearing, all interested persons, corporations or political subdivisions were afforded the opportunity to present evidence regarding the proposed annexation; and

WHEREAS, no written objection to the proposed annexation was filed with the Board of Aldermen of the City of Bonne Terre, Missouri within fourteen days after the public hearing; and

WHEREAS, the Board of Aldermen of the City of Bonne Terre, Missouri, does find and determine that said annexation is reasonable and necessary to the proper development of the city; and

WHEREAS, the city is able to furnish normal municipal services to said area within a reasonable time after annexation; now

THEREFORE, be it ordained by the Board of Aldermen of the City of Bonne Terre, Missouri as follows:

SECTION I: Pursuant to the provision of Section 71.012 RSMo, the following described real estate is hereby annexed into the City of Bonne Terre, Missouri, to wit:

SECTION II: The boundaries of the City of Bonne Terre, Missouri, hereby are altered so as to encompass the above described tract of land lying adjacent and contiguous to the present corporate limits.

SECTION III: The City Clerk of the City of Bonne Terre, Missouri hereby is ordered to cause three certified copies of this Ordinance to be filed with the St. Francois County Clerk.

SECTION IV: This Ordinance shall be in full force and effect from after its passing by the Board of Aldermen and approval by the Mayor.
