ORDINANCE NO. 202011

AN ORDINANCE APPROVING THE PROPOSED AMENDMENT OF BLOCK 76, LOTS 2 & 3, OF THE TOWN OF BONNE TERRE, ST FRANCOIS COUNTY, STATE OF MISSOURI, BEING A SUBDIVISION PLAT, RECORDED IN PLAT BOOK 5, AT PAGES 4 & 5, AT THE OFFICE OF THE RECORDER OF DEEDS OF ST FRANCOIS COUNTY, MISSOURI, COMMONLY REFERRED TO AS 215 EAST OAK STREET, BONNE TERRE, ST. FRANCOIS COUNTY MISSOURI, AS SET FORTH IN THE AMENDED PLAT ATTACHED HERETO AND MADE A PART HEREOF.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BONNE TERRE, MISSOURI, AS FOLLOWS:

SECTION 1. The City of Bonne Terre, Missouri has received a request to amend Block 76, Lots 2 & 3, of the Town of Bonne Terre, St Francois County, State of Missouri, being a Subdivision Plat, Recorded in Plat Book 5, at Pages 4 & 5, at the Office of the Recorder of Deeds, of St Francois County, Missouri, commonly referred to as 215 East Oak, Bonne Terre, St. Francois County, Missouri, as set forth in the Amended Plat, attached hereto and made a part hereof.

SECTION 2. Following consideration the Board of Alderman of the City of Bonne Terre, Missouri, do approve the subdivision of Block 76, Lots 2 & 3, of the Town of Bonne Terre, St Francois County, State of Missouri, being a Subdivision Plat, Recorded in Plat Book 5, at Pages 4 & 5, at the Office of the Recorder of Deeds of St Francois County, Missouri, commonly referred to as 215 East Oak, Bonne Terre, St. Francois County, Missouri and the plat is hereby amended, as set forth in the amended plat attached hereto and incorporated herein.

SECTION 3. All Municipal Ordinances, or parts thereof, in conflict with this Ordinance are hereby repealed, as to the extent they cannot be reconciled herewith.

SECTION 4. This Ordinance shall be in full force and effect from and after its date of passage and approval.
