AN ORDINANCE APPROVING A REQUEST TO, AND THE REPLATTING OF A PORTION OF, THE REAL PROPERTY COMMONLY KNOWN AS INDUSTRIAL ROAD, BONNE TERRE, ST FRANCOIS COUNTY, MISSOURI, PART OF U.S. SURVEY NO. 3099, TOWNSHIP 37 NORTH, RANGE 4 EAST, OF THE 5TH PRINCIPAL MERIDIAN AS DESCRIBED AND, AS SET FORTH IN “EXHIBIT A”, ATTACHED HERETO AND INCORPORATED HEREIN.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF BONNE TERRE, MISSOURI AS FOLLOWS:


SECTION 1. The owners of the real property, as legally described in “Exhibit A”, which is attached hereto and incorporated herein, located in the City of Bonne Terre, County of St. Francois, State of Missouri, have submitted the proper forms and requests to the City of Bonne Terre Planning and Zoning Committee and said application has received favorable recommendation for the proposed Amendment to, and the Replatting of a Portion of, the real property commonly referred to as Industrial Road, St Francois County, Missouri, Part of U.S. Survey No. 3099, Township 37 North, Range 4 East, of the 5th Principle Meridian and as set forth in “Exhibit A”.

SECTION 2. Upon request of the owners of the real property, as legally described in “Exhibit A”, the Council does hereby ordain and replat a portion of, the real property commonly referred to as Industrial Road, Bonne Terre, St Francois County, Missouri, Part of U.S. Survey No. 3099, Township 37 North, Range 4 East, of the 5th Principal Meridian, as described and as set forth in “Exhibit A” by subdividing said parcel and creating “Tract I-2-1 and Tract I-2-2”, as shown, and legally described in “Exhibit A”.

SECTION 3. In consideration of the favorable recommendation for approval of said request to approve the Replatting of a portion of, the real property commonly referred to as Industrial Road, Bonne Terre, St Francois County, Missouri, Part of U.S. Survey No. 3099, Township 37 North, Range 4 East, of the 5th Principal Meridian the Board of Alderman of the City of Bonne Terre, Missouri, do hereby approve the Proposed Amendment, and the Replatting of the real property, as legally described in “Exhibit A”, attached hereto, located in the City of Bonne Terre, County of St. Francois, State of Missouri and direct the applicant to record with the Recorder of Deeds, for St. Francois County, Missouri the appropriate certified plats and a certified copy of this Ordinance therewith.

SECTION 4. This Ordinance shall be in full force and effect from and after its date of passage and approval.
