AN ORDINANCE APPROVING A REQUEST TO, AND THE REPLATTING OF A PORTION OF, THE REAL PROPERTY COMMONLY KNOWN AS THE ORCHARD LLC., BONNE TERRE, ST FRANCOIS COUNTY, MISSOURI, PART OF U.S. SURVEY, TOWNSHIP 37 NORTH, RANGE 4 EAST, AS DESCRIBED IN DEED BOOK1579, PAGE 2083 AND, AS SET FORTH IN "EXHIBIT A", ATTACHED HERETO AND INCORPORATED HEREIN.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF BONNE TERRE, MISSOURI AS FOLLOWS:

SECTION 1. SECTION 3. In consideration of the favorable recommendation for approval of said request to approve the Replatting of a portion of, the real property commonly referred to as The Orchard LLC., Bonne Terre, St Francois County, Missouri, Part of U.S. Survey No. 467, Township 37 North, Range 4 East, as described in Deed Book 1579, Page 2083 the Board of Alderman of the City of Bonne Terre, Missouri, do hereby approve the Proposed Amendment, and the Replatting of the real property, as legally described in "Exhibit A", attached hereto, located in the City of Bonne Terre, County of St. Francois, State of Missouri and direct the applicant to record with the Recorder of Deeds, for St. Francois County, Missouri the appropriate certified plats and a certified copy of this Ordinance therewith.
