AN ORDINANCE GRANTING AUTHORIZATION TO THE CITY ADMINISTRATOR, SHAWN KAY, TO EXECUTE A REAL ESTATE PURCHASE CONTRACT WITH GRINDSTAFF TRUCKING, LLC FOR THE PURCHASE OF 10 ACRE TRACT OF LAND, COMMONLY REFERRED TO AS INDUSTRIAL ROAD, LOCATED WITHIN THE CITY OF BONNE TERRE, ST FRANCOIS COUNTY, MISSOURI.
