AN ORDINANCE GRANTING AUTHORIZATION TO THE CITY ADMINISTRATOR, SHAWN KAY, TO EXECUTE A REAL ESTATE PURCHASE CONTRACT WITH IDA OF ST. FRANCOIS COUNTY & SEMO REGIONAL PLANNING COMMISION FOR THE PURCHASE OF 2.48 ACRE TRACT OF LAND, COMMONLY REFERRED TO AS INDUSTRIAL ROAD, LOCATED WITHIN THE CITY OF BONNE TERRE, ST FRANCOIS COUNTY, MISSOURI.
