Local Law No. 2 of the year 2024

A local Law amending Chapter 57 entitled "Shellfish," Article VI entitled "Designated Management Areas and Winter Grounds," Section 57-34 entitled "Management Areas," "57 Attachment 1, Exhibit A, Management Areas" of the Code of the Town of Brookhaven

Be enacted by the Town Board of the Town of Brookhaven as follows:

Section 1. Legislative Intent. This local law amendment to Chapter 57 entitled "Shellfish," Article VI entitled "Designated Management Areas and Winter Grounds," Section 57-34 entitled "Management areas," "57 Attachment 1, Exhibit A, Management Areas" of the Code of the Town of Brookhaven will expand the Management Area within Bellport Bay.

Section 2. Text Amendment. Chapter 57 entitled "Shellfish," Article VI entitled "Designated Management Areas and Winter Grounds," Section 57-34 entitled "Management areas," "57 Attachment 1, Exhibit A, Management Areas" is hereby amended as follows:

§ 57-34. Management areas

MANAGEMENT AREAS

A-10. Bellport Bay: Management Area

BEGINNING at a point located at 40° 44.8080' N latitude and 72° 56.4212' W longitude, thence proceeding southerly from that point to a point located at 40° 44.7830' N latitude and 72° 56.4187' W longitude, thence proceeding easterly to a point located at 40° 45.0195' N

latitude and 72° 56.1678' W longitude thence proceeding northerly to a point located at 40°45.0302' N latitude and 72° 56.1822' W longitude and thence proceeding westerly to the point or place of BEGINNING.

Southwest Corner: 40° 44.7830' N 72° 56.4187' W
Southeast Corner: 40° 45.0195' N 72° 56.1678' W
Northeast Corner: 40° 45.0302' N 72° 56.1822' W

Section 3. Authority. The Town Board is vested with the authority to make these amendments pursuant to Town Law Sections 130(15) and 130(18) and pursuant to Municipal Home Rule Law Section 10 and in conformance with Municipal Home Rule Law Section 20.

Section 4. Effective date. This local law shall become effective immediately upon filing with the Secretary of State of the State of New York.
