BE IT ORDAINED AND ENACTED by the Council of the Borough of Brookville, Jefferson County, Pennsylvania, and IT IS HEREBY ORDAINED AND ENACTED by the authority of the same as follows:

1. That a tax be and the same is hereby levied on all real property within the said municipality subject to taxation for the fiscal year 2019 as follows:

That a Local Services Tax (LST) of \$52.00 shall be and the same is hereby levied upon all wage earners employed within the Borough of Brookville earning greater than \$12,000.00 and subject to taxation for the fiscal year of 2019. \$5.00 of the LST for each and every wage earner subject to taxation shall be tendered to the Brookville Area School District.
- 4. That a per capita tax of \$5.00 be and the same is hereby levied upon all residents of the said municipality subject to taxation for the fiscal year 2019.
