**ORDINANCE NUMBER 1108**

**AN ORDINANCE FIXING THE TAX  
RATE FOR THE YEAR 2021**

BE IT ORDAINED AND ENACTED by the Council of the Borough of Brookville, Jefferson County, Pennsylvania, and IT IS HEREBY ORDAINED AND ENACTED by the authority of the same as follows:

1. That a tax be and the same is hereby levied on all real property within the said municipality subject to taxation for the fiscal year 2021 as follows:

Tax rate for general purposes, the sum of on each dollar of assessed valuation;	14.29 mills
For street lighting purposes, the sum of on each dollar of assessed valuation;	0.90 mills
For fire protection purposes, the sum of on each dollar of assessed valuation;	1.50 mills
For library purposes, the sum of on each dollar of assessed valuation;	0.225 mills

TOTAL	16.915 mills

2. That a tax be and the same is hereby levied on all occupations within said municipality subject to taxation for the fiscal year 2021 as follows:

The rate for general purposes, the sum of on each dollar of assessed valuation;	30.0 mills
For street lighting purposes, the sum of on each dollar of assessed valuation;	3.00 mills
For fire protection purposes, the sum of on each dollar of assessed valuation;	3.00 mills

TOTAL	36.00 mills

3. That a Local Services Tax (LST) of \$52.00 shall be and the same is hereby levied upon all wage earners employed within the Borough of Brookville earning greater than \$12,000.00 and subject to taxation for the fiscal year of 2021. \$5.00 of the LST for each and every wage earner subject to taxation shall be tendered to the Brookville Area School District.

4. That a per capita tax of \$5.00 be and the same is hereby levied upon all residents of the said municipality subject to taxation for the fiscal year 2021.
