# AN ORDINANCE CALLING AN ELECTION IN THE CITY OF CASSVILLE, MISSOURI.

## BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF CASSVILLE, MISSOURI, AS FOLLOWS:

**Section 1.** The Board of Aldermen finds it necessary and hereby declares its intent to continue to impose a capital improvement sales tax pursuant to Section 94.577 R.S.Mo. for the purpose of funding capital improvements, including the operation and maintenance of capital improvements, for the City.

**Section 2.** An election is hereby ordered to be held in the City of Cassville, Missouri, on April 2, 2024, on the following question:

#### **QUESTION**

Shall the City of Cassville, Missouri, continue to impose a capital improvement sales tax of one half of one percent for the purpose of funding capital improvements, including the operation and maintenance of capital improvements, and which may include the retirement of debt under previously authorized bonded indebtedness?

**Section 3.** The form of the Notice of Election for said election, a copy of which is attached hereto and made a part hereof, is hereby approved.

**Section 4.** The City Clerk is hereby authorized and directed to notify the County Clerk of Barry County, Missouri, of the adoption of this Ordinance no later than 4:00 P.M. on January 23, 2024, and to include in said notification all of the terms and provisions required by Chapter 115 of the Revised Statutes of Missouri, as amended.

Section 5. This Ordinance shall be in full force and effect from and after its passage.
