26 **SECTION 1. BE IT ENACTED BY THE COUNTY COMMISSIONERS OF CHARLES COUNTY, MARYLAND, that the Laws of Charles County, Maryland read as follows:**

27 * * * * *

28 §287-9: Violations and penalties.

29 A. Any person who violates any provision of §287-8 of this article is guilty of a misdemeanor
30 and on conviction is subject to a fine:

31 (1) Of \$20 for each violation of any of the provisions in §287-8, A, B, C or E of this

(2) Of \$500 for each violation of the provisions of §287-8 D of this article.

B. Each day a violation of this article continues shall constitute a separate offense.

SECTION 2. BE IT FURTHER ENACTED that this act shall take effect forty-five (45) calendar days after it becomes law.
