22 **SECTION 1. BE IT ENACTED BY THE COUNTY COMMISSIONERS OF**
23 **CHARLES COUNTY, MARYLAND, that the Laws of Charles County, Maryland read as**

- 29 (1) The Treasurer shall invest in short-term United States government securities or

of the United States Congress, in each case, with stated maturities of the investments not exceeding TWO (2) YEARS [365 days] or the local government investment pool established in SECTION 17-301 ET SEQ. OF THE LOCAL GOVERNMENT Article [95, § 22g] of the Annotated Code of Maryland or deposit in income-producing bank accounts, such County funds as are not required to be used for immediate disbursement or expenditures for County purposes

SECTION 2. BE IT FURTHER ENACTED that this act shall take effect forty-five (45) calendar days after it becomes law.




