AN ORDINANCE OF THE BOROUGH OF CHESTER, MORRIS COUNTY, STATE OF NEW JERSEY, AMENDING PART II (GENERAL LEGISLATION), CHAPTER 127 (MUNCIPAL FEES), SECTION 1 (FEES ESTABLISHED) OF THE CODE OF THE BOROUGH OF CHESTER TO INCREASE THE FEES ASSOCIATED WITH CHAPTER 197 (SOIL CONTROL) AND CHAPTER 204 (STORM MANAGEMENT)

WHEREAS, municipalities are empowered to make, amend, repeal, and enforce its ordinances pursuant to Statute (N.J.S.A. 40:48-1, et seq.); and

WHEREAS, municipalities are required by Statute to follow specific procedures for the passage of ordinances (<u>N.J.S.A.</u> 40:49-2 <u>et seq.</u>); and

WHEREAS, the administrative and professional staff have reviewed Chapter 127 (FEES) of the Code of the Borough of Chester and made recommendations for changes and updates thereto, and

WHEREAS, the Finance Committee of the Chester Borough Council as recommended acceptance of the proposed changes and update to Chapter 127 (FEES) of the Code of the Borough of Chester; and

WHEREAS, the Mayor and Council of the Borough of Chester have determined that it is in the best interests of the residents of the Borough of Chester that Chapter 127 (MUNICIPAL FEES) of the Code of the Borough of Chester be changed and updated; and

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Borough of Chester, County of Morris, State of New Jersey that Part II (GENERAL LEGISLATION), Chapter 127 (MUNICIPAL FEES), Section 1(FEES ESTABLISHED) of the Code of the Borough of Chester is hereby amened as follows:

SECTION 1: §127-1 concerning Ch. 197 (Soil Control), Section 197-5 fees is hereby amended as follows:

SECTION 2: §127-1 concerning Ch. 197 (Soil Control), Section 197-21 fees is hereby amended as follows:

Major soil moving, additional escrow, per	
cubic yard of soil to be moved	\$0.05

SECTION 3: §127-1 concerning Ch. 204 (Storm Management) Section 204-4 is hereby amended to add the following:
