## **ORDINANCE 2023-05**

ORDINANCE PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS OR PURPOSES TO BE UNDERTAKEN BY THE BOROUGH OF CHESTER, IN THE COUNTY OF MORRIS, NEW JERSEY, AND APPROPRIATING \$131,400 THEREFOR FROM MONEYS IN THE CAPITAL IMPROVEMENT FUND OF THE BOROUGH.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE BOROUGH OF CHESTER, IN THE COUNTY OF MORRIS, NEW JERSEY, AS FOLLOWS:

<u>Section 1.</u> The improvements described in Section 3 of this ordinance are hereby authorized as general improvements to be made or acquired by the Borough of Chester, County of Morris, State of New Jersey, and there is hereby appropriated therefor the sum of \$131,400.

Section 2. There is more than \$131,400 in funds available in the Capital Improvement Fund of the Borough of Chester.

Section 3. The improvements hereby authorized and the several purposes for the financing of which the appropriation is made as provided in Section 1 of this ordinance include but are not limited to the following: (i) the acquisition by purchase of new and additional equipment for use by the Departent of Public Works of the Borough including one (1) truck, (ii) the purchase of a leaf blower, (iii) the purchase of a mower, (iv) the purchase and installation of an awning for the front door of Borough Hall and (v) the installation of electrical lines and connection at Grove Street Park, together with for all the aforesaid all equipment, attachments, accessories, site work, work, materials, costs and expenses necessary therefor or incidental thereto, all as shown on and in accordance with the plans and specifications therefor on file or to be filed in the Office of the Borough Clerk and are hereby approved.

Section 4. The capital budget or temporary capital budget of the Borough of Chester is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services, are on file with the Borough Clerk and are available for public inspection.

Section 5. This ordinance shall take effect after publication after final passage as provided by law.
