## **ORDINANCE 2023 - 10**

AN ORDINANCE OF THE BOROUGH OF CHESTER, MORRIS COUNTY, STATE OF NEW JERSEY, AMENDING PART II (GENERAL LEGISLATION) TO CREATE A NEW CHAPTER 60 (FINANCES) TO SET FORTH THE ESTABLISHMENT OF CERTAIN FEES AND AMENDING CHAPTER 127 (MUNCIPAL FEES), SECTION 1 (FEES ESTABLISHED) OF THE CODE OF THE BOROUGH OF CHESTER REFLECT THOSE FEES AND INCREASE THE FEE FOR THE USE OF THE OUTDOOR GRILL AT THE FIELD HOUSE.

**WHEREAS**, municipalities are empowered to make, amend, repeal, and enforce its ordinances pursuant to Statute (N.J.S.A. 40:48-1, et seq.); and

**WHEREAS**, municipalities are required by Statute to follow specific procedures for the passage of ordinances (N.J.S.A. 40:49-2 et seq.); and

**WHEREAS,** the administrative and professional staff have reviewed Chapter 127 (FEES) of the Code of the Borough of Chester and made recommendations for changes and updates thereto, and

**WHEREAS**, the Ordinance and Finance Committees of the Chester Borough Council have recommended acceptance of the proposed changes and update to the Code of the Borough of Chester; and

**WHEREAS**, the Mayor and Council of the Borough of Chester have determined that it is in the best interests of the residents of the Borough of Chester to create a new Chapter 60 (FINANCES) to establish certain fees to be reflected in Chapter 127 (MUNICIPAL FEES) of the Code of the Borough of Chester; and

**NOW, THEREFORE, BE IT ORDAINED**, by the Council of the Borough of Chester, County of Morris, State of New Jersey that Part II (GENERAL LEGISLATION) is amended to create a new Chapter 60 (FINANCES) and amending Chapter 127 (MUNICIPAL FEES), Section 1(FEES ESTABLISHED) of the Code of the Borough of Chester as follows:

## **SECTION 1:**

## **Chapter 60 (Finances)**

§60-1 **Returned Checks.** The collection of funds, accounting thereof, and the operations of the Borough are negatively impacted when deposited checks are not honored by the Borough's banking institutions and are returned as uncollectable. Pursuant to N.J.S.A. 40:5-18, whosoever issues or tenders a check or other written instrument to the Borough which is not honored by a banking institution in which Borough has deposited that check due to insufficient funds, shall be responsible for replacement of that check or other written instrument with good and negotiable

funds together with a "Returned Check Fee", the amount of which shall be set forth in §127-1 (Fees) of the Borough Code.

§60-2 **Facility User Fees.** The Borough owns various facilities within the Borough, such as the Gazebo on Main Street, Municipal Field, the Field House, which is made available for private use by individuals and organizations. Facility User Fees shall be fixed from time to time and shall be set forth in §127-1 (Fees) of the Borough Code.

**SECTION 2:** §127-1 is hereby amended to include a Return Check Fee pursuant to Chapter 60 (Finances), §60-1 in the amount of \$20.00.

**SECTION 3:** §127-1 concerning Ch. 9, Art. II (Board of Recreation Commissioners, is hereby amened to replace the foregoing reference with Chapter 60 (Finances), §60-3 (Facility User Fees) keeping the existing fees set forth therein, but amending the additional fee for use of the outdoor grill to \$50.00.

**SECTION 4:** If any Chapter, Article, Section or Subsection, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by any court of competent jurisdiction such decisions shall not affect the remaining portions of this Ordinance.

**SECTION 5:** All ordinances or rules or regulations of the Borough of Chester, which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 6:** This ordinance shall take effect upon passage and publication according to law.
