A local law _____ amend Vehicle and Traffic Regulations (Section 270-14E) – parking reserved in designated locations for delivery truck unloading

Parking shall be reserved for delivery truck unloading Monday to Saturday, 6am to 12pm in the following locations. Outside of those days and times, these locations shall accommodate vehicular parking in conformity with regulations elsewhere in this chapter.

- (1) On west side of Pioneer Street south of Pioneer Alley for a length of 40 feet (2 parking spaces).
- (2) On the west side of Pioneer Street south of Stagecoach Lane for a length of 88 feet (4 parking spaces).
- (3) On the north side of Main Street extending from 92 Main Street to 100 Main Street for a length of 92 feet (4 parking spaces) allowing for four parking spaces east of the loading zone and west of Pioneer Street and one parking space in front of 100 Main Street.
- (4) On the north side of Main Street east of the entrance to the Cooper Inn (tax parcel 115.18-3-27.00) extending east for a length of 70 feet (3 parking spaces).




