**ORDINANCE NO. 2112**

**AN ORDINANCE OF THE CITY OF COTTLEVILLE, MISSOURI, AMENDING SCHEDULE II OF TITLE III OF THE MUNICIPAL CODE OF THE CITY OF COTTLEVILLE, MISSOURI, BY DELETING TABLES II-A, II-B, AND II-C IN THEIR ENTIRETY; AND ENACTING, IN LIEU THEREOF, NEW TABLES II-A, II-B, II-C, AND II-D, RELATED TO STOP SIGNS**

**WHEREAS**, pursuant to § 304.120.2, RSMo., “Municipalities, by ordinance, may . . . [m]ake additional rules of the road or traffic regulations to meet their needs and traffic conditions; [and] . . . [r]equire vehicles to stop before crossing certain designated streets and boulevards;” and

**WHEREAS**, the Board of Aldermen of the City of Cottleville, Missouri (the “Board of Aldermen”), desires to improve traffic safety within the City; and

**WHEREAS**, the Board of Aldermen recognizes that traffic can and should be controlled in order to promote the health, safety and welfare of the residents of the City; and

**WHEREAS**, the Board of Aldermen desires to amend the City’s stop sign regulations.

**NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF COTTLEVILLE, MISSOURI, AS FOLLOWS:**

**SECTION 1.** That Schedule II-Stop Signs of Title III-Traffic Code of the Municipal Code of the City of Cottleville, Missouri, be and is hereby amended by deleting Table II-A thereto in its entirety, and enacting, in lieu thereof, a new Table II-A to read as follows:

**SECTION 2.** That Schedule II-Stop Signs of Title III-Traffic Code of the Municipal Code of the City of Cottleville, Missouri, be and is hereby amended by deleting Table II-B thereto in its entirety, and enacting, in lieu thereof, a new Table II-B to read as follows:

**TABLE II-B Four-Way Stop.**

**Intersection**

Buckington Street at Manington Street, from all directions  
 Bucking Street at Oxborough Street, from all directions  
 Danielle Drive and Brittany Cove, from all directions  
 Danielle Drive and Brittany Timbers Drive, in all directions  
 Ohms Road at St. Peters-Cottleville Road, in all directions

**SECTION 3.** That Schedule II-Stop Signs of Title III-Traffic Code of the Municipal Code of the City of Cottleville, Missouri, be and is hereby amended by deleting Table II-C thereto in its entirety, and enacting, in lieu thereof, a new Table II-C to read as follows:

**TABLE II-C, Three Way Stop**

**Intersection**

On Main Street at the intersection with Oak Street, in both directions  
 On Oak Street at the intersection with Main Street, Traveling West  
 Miralago Way and Vistalago Place (easternmost intersection) from all directions  
 Miralago Way and Vistalago Place (westernmost intersection) from all directions

**SECTION 4.** That Schedule II-Stop Signs of Title III-Traffic Code of the Municipal Code of the City of Cottleville, Missouri, be and is hereby amended by adding a new Table II-D thereto, to read as follows:

**TABLE II-D, Two Way Stop**

**Intersection**

On Lime Street, at the intersection with Main Street, in both directions

**SECTION 5.** The City Traffic Engineer is hereby authorized and directed to install appropriate signage reflecting the traffic regulations pertaining to the three-way stops established in Section 1 of this Ordinance consistent with Section 1 of this Ordinance.

**SECTION 6.** Violations of the traffic regulations and fines pertaining to the three-way stops established in Section 1 of this Ordinance be prosecuted pursuant to the Traffic Code of the City of Cottleville and will be controlled and enforced by the Cottleville Police Department.

**SECTION 7. Savings Clause:** Except as expressly set forth herein, nothing contained in this Ordinance shall in any manner be deemed or construed to alter, modify, supersede, supplant or otherwise nullify any other Ordinance of the City or the requirements thereof whether or not relating to or in any manner connected with the subject matter hereof.

**SECTION 8. Severability Clause:** If any term, condition, or provision of this Ordinance shall, to any extent, be held to be invalid or unenforceable, the remainder hereof shall be valid in all other respects and continue to be effective and each and every remaining provision hereof shall be valid and shall be enforced to the fullest extent permitted by law, it being the intent of the Board of Aldermen that it would have enacted this Ordinance without the invalid or unenforceable provisions. In the event of a subsequent change in applicable law so that the provision which had been held invalid is no longer invalid, said provision shall thereupon return to full force and effect without further action by the City and shall thereafter be binding.

**SECTION 9. Effective Date:** This Ordinance shall be in full force and take effect from and after its final passage and approval.
