ORDINANCE NO. 5437

INTRODUCED BY ALDERMAN MABIE

AN ORDINANCE AMENDING CHAPTER 2 OF THE MUNICIPAL CODE OF THE CITY OF CRESTWOOD, TO ADD A NEW SECTION RELATED TO AN ALTERNATE SEAL OF THE CITY

WHEREAS, The City of Crestwood, Missouri (the "City") has all of the powers enumerated by the statutes and Constitution of this state now or hereafter applicable to constitutional charter cities including the power to designate one or more City seals; and

WHEREAS, the City has been offered the opportunity by the Missouri Department of Transportation ("MoDOT") to display a City seal on Custom City Limit signs subject to an agreement of the City and MoDOT; and

WHEREAS, the City Board of Aldermen unanimously approved Bill Number 22-78 on February 28, 2023, and such Bill was approved by the Mayor and enacted as Ordinance Number 5340, which Ordinance was an "ORDINANCE AUTHORIZING THE CITY OF CRESTWOOD TO PURCHASE TWO CUSTOM HIGHWAY SIGNS AND AUTHORIZING THE CITY ADMINISTRATOR AND MAYOR TO NEGOTIATE AND EXECUTE A CONTRACT WITH THE MISSOURI DEPARTMENT OF TRANSPORATION TO THAT EFFECT"; and

WHEREAS, the Board of Aldermen wishes to clarify the City seal that should be displayed on the Custom Highway Signs described in Ordinance 5340, and designate an alternate City seal for any other proper purpose; and

WHEREAS, the Board of Aldermen finds that the amendment to Section 2-1 of Chapter 2 would be in the best interest of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE

CITY OF CRESTWOOD, MISSOURI, AS FOLLOWS:

SECTION 1: Article I of Chapter 2, of the Municipal Code of the City of Crestwood,

Missouri is hereby amended to read as follows (with added language appearing in red text):

Sec. 2-1 Seal of City.

- (a) An official seal is hereby adopted for the City. The official seal shall be retained in the office of the City Clerk/Collector. It shall consist of a metallic disk, not more than 2 1/2 inches in diameter, with the words "City of Crestwood, Missouri," engraved in the border, and the coat of arms of the state engraved in the center portion of the disk.
- (b) The City Clerk/Collector shall affix the seal to, and countersign, all commissions and other official acts, certified copies and attestations, and to all other instruments when required or authorized by the Mayor.
- (c) An alternate City seal, the form and colors of which are reflected on "Exhibit A" attached to Ordinance 5438 and incorporated in this section as though more fully set out, is hereby adopted for the City. This alternate City seal may be used as the seal of the City for any purpose when so designated by the Board of Aldermen.

SECTION 2: The alternate City seal of the City described in Code Section 2-1(c) is

designated by the Board of Aldermen of the City of Crestwood, Missouri to be the City seal

displayed on the Custom Highway Signs described in Ordinance 5340.

SECTION 3: The remaining provisions of Chapter 2 of the Municipal Code of the City of

Crestwood shall remain in full force and effect.

SECTION 4: This Ordinance shall be in full force and effect from and after its passage by the Board of Aldermen and its approval by the Mayor.
