

**ORDINANCE OF THE TOWNSHIP OF DEPTFORD AMENDING SECTION 7-41.3  
OF THE TOWNSHIP CODE TO PERMIT TITLE 39 ENFORCEMENT  
WITHIN THE PRIVATE AND SEMI-PRIVATE AREAS OF THE  
GEORGETOWN MEWS COMMUNITY**

**WHEREAS**, the Georgetown Mews Homeowner's Association has submitted correspondence to Deptford Township (the "Township") requesting enforcement of Title 39 within the private and semi-private areas of the community; and

**WHEREAS**, specifically the streets where Title 39 would be enforced include Sal Corma Drive, Georgetown Road, and Buddy Powell Lane; and

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Township Council of the Township of Deptford, in the County of Gloucester and State of New Jersey, as follows:

**Section 1.** Section 7-41.3 of the Township Code shall be amended to add a Section 7-41.3(d) which shall read as follows:

**§7-41.3(d)**

Sal Corma Drive, Georgetown Road, and Buddy Powell Lane within Georgetown Mews. Pursuant to N.J.S.A. 39:5A-1, Subtitle 1, Title 39 of the Revised Statutes of the State of New Jersey are hereby made applicable to the private roads known as Sal Corma Drive, Georgetown Road, and Buddy Powell Lane located within the lands and premises owned by the Georgetown Mews Homeowner's Association.


**Section 2. Repealer.** All ordinances or parts of ordinances inconsistent or in conflict with this Ordinance are hereby repealed as to said inconsistencies and conflict.


**Section 3. Severability.** If any section, part of any section, or clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional, such decision shall not effect the remaining provisions of this ordinance. The governing body of the Township of Deptford declares that it would have passed the ordinance and each section and subsection thereof, irrespective of the fact that any one or more of the subsections, sentences, clauses or phrases may be declared unconstitutional or invalid.

**Section 4. Effective Date.** The ordinance shall take effect immediately upon passage and publication according to law.


