

**AN ORDINANCE AMENDING REVISED GENERAL ORDINANCES OF
THE TOWNSHIP OF DEPTFORD, CHAPTER VII, SECTION 7-13, ENTITLED,
"PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS" WITHIN
THE TOWNSHIP OF DEPTFORD, COUNTY OF GLOUCESTER,
STATE OF NEW JERSEY**

WHEREAS, the Mayor and Township Council of the Township of Deptford, County of Gloucester, deems it necessary to amend traffic regulations.

NOW, THEREFORE, be it ordained by the Mayor and Township Council of the Township of Deptford, County of Gloucester, that Chapter VII of the Revised General Ordinances of the Township of Deptford entitled, "Parking Prohibited at All Times on Certain Streets" is hereby amended to read by adding the following locations:

SECTION 1. Section 7-13 is hereby amended to read as follows:


<u>NAME</u>	<u>ZONE</u>	<u>SIDES</u>	<u>LOCATION</u>
Cooper Street (County Route 534)	Zone 3	Southerly	Certain areas designated as the southerly side of Cooper Street for a distance of 418 feet, plus or minus, from the intersection of Block 577, lots 48, 49 and 50 to be designated as no parking.
Kohler Avenue	Zone 3	North	The northwest side of Kohler Avenue between the property known as Budds Pools, Block 179, Lot 1 and NJ Route 47 for a distance of approximately 240 feet, plus or minus, shall be designated as no parking.

SECTION 2. Any provisions of any Ordinance inconsistent with the provisions of this Ordinance are hereby repealed.

SECTION 3. If any sections or provisions of this Ordinance shall be ruled invalid, such ruling shall apply only to the sections or provisions ruled invalid and the remained of the Ordinance should be deemed valid and remain in full force and effect.


SECTION 4. This Ordinance shall take effect twenty (20) days after final passage pursuant to N.J.S.A. 40:69A-181.


